Your 2022–2023 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You must complete and sign this worksheet, include any required documents, and upload via Net Partner to the Financial Aid Office at Belmont Abbey College. We may ask for additional information. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.

- Get Transcript ONLINE – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript ONLINE." Request Verification of Non-filing Letter.
- Paper Request Form – Go to www.irs.gov, print, complete and mail to the IRS Form 4506-T.

2. Tax Return Filers

Important Note: If the student (and spouse, if married) filed, or will file, an amended 2020 IRS tax return, filed separate tax returns or had a change in marital status after December 31, 2020, you must contact the financial aid administrator before completing this section.

Instructions: Complete this section if the student (and spouse, if married) filed a 2020 IRS income tax return. *The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at studentaid.gov. If the student has not already used the tool, go to studentaid.gov, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if the student is eligible to use the IRS DRT.*

- Get Transcript ONLINE – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript ONLINE." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript."
- Automated Telephone Request – 1-800-908-9946 option #2 or Paper Request Form – Go to www.irs.gov, print, complete and mail to the IRS Form 4506-T.

Warning: If you purposely give false or misleading information on this worksheet, you may be fined, be sentenced to jail, or both.
