# 2. Tax Return Filers

**Important Note:** If the student (and spouse, if married) filed, or will file, an <u>amended</u> 2020 IRS tax return, filed separate tax returns or had a change in marital status after December 31, 2020, you must contact the financial aid administrator before completing this section.

**Instructions**: Complete this section if the student (and spouse, if married) <u>filed</u> a 2020 IRS income tax return. The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at <u>studentaid.gov</u>.
