Your 2023–2024 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent whose information was reported on the FAFSA must complete and sign this worksheet, include any required documents, and upload via Net Partner to the Financial Aid Office at Belmont Abbey College. We may ask for additional information. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.

- Paper Request Form – Go to www.irs.gov, print, complete and mail to the IRS Form 4506T-EZ or Form 4506-T.

D. Parent's Income Information to Be Verified *Instructions:* The information below applies to each parent included in the household. Complete item number one, if you did not file a 2021 tax return or complete item number two, if you did file a 2021 tax return, *but not both items.*

1. Nontax Filers

- One or both parents will not file and are not required to file a 2021 tax return with the IRS. - Get Transcript ONLINE – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript ONLINE." Request Verification of Non-filing Letter.
- Paper Request Form – Go to www.irs.gov, print, complete, and mail to the IRS Form 4506-T.

You may now proceed to the parent signature page.

2. Tax Return Filers

Important Note: The instructions below apply to each parent included in the household. Notify the financial aid office if the parents filed separate IRS income tax returns for 2021 or had to file an amended return or had a change in marital status after December 31, 2021.
